

1. The primary purpose of the organization is to instruct and train church pastors and laypersons to communicate the Bible effectively in their own culture. These projects are carried out in North America as well as internationally.

2. Part II Balance Sheets: Continuing in the initial organizational years, the organization operated on a cash basis and utilized volunteer's equipment, thus, accumulated no assets to be reflected on a balance sheet. Likewise, there are no liabilities. Thus, the balance sheet simply reflects cash on hand.

3. Statement of Program Accomplishments: The primary purpose of the organization is carried out through the conducting of projects throughout the world. A summary of those projects follow:

In 2016-2017, there were six countries in which seven projects each lasting two weeks were carried out. These countries include Cuba with two projects, India, Myanmar, Vietnam, Romania, and Ukraine. There were over 180 participants (pastors) in these projects. All projects including books, supplies, venues, etc were financially underwritten by CrossTalk Global. Total Expenditure - \$135,840.

In 2016-2017, there were four events in North America involving week-end seminars of instruction at which over 125 participants attended. These events were held in California (2), Massachusetts, and Kansas. The condensed format is similar to international projects instructing in the same principles utilized in the international projects to effectively communicate the Bible in one's own culture.

In North America these expenditures totaled just over \$7,000.
