- Learn that they have the power to make a positive difference in the world - today
- Experience the power that giving of themselves has to enrich their lives
- Experience the value of the 5C's of positive youth development - competence confidence, character connection and caring as they act on the 6th C - contribution. We believe this experience and action help broaden the scope of what they believe they can reach for and want to accomplish as they grow into adults.
