Oihana Holomoana is an academic program that seeks to maximize the academic outcomes of Native Hawaiian students through the development, refinement, and implementation of Hawaiian cultures based curriculum. Oihana Holomoana is also a maritime career pathways program, working to prepare youth academically for future careers in the maritime industry. Oihana Holomoana utilizes Hawaiian culture, voyaging traditions, and contemporary maritime skills in designing and implementing curriculum in reading, math, and science. Curriculum development is conducted in partnership with focus groups comprised of school teachers. Teachers at participating schools receive professional development training in using the curriculum and help to assess and refine the curriculum over time in order to maximize student academic outcomes. Last year Oihana Holomoana served over 240 participants through this programming.

Students learn maritime as well as traditional navigation skills over several weekends, culminating in a 10-day open ocean voyage where students are able to put their traditional and contemporary skills to the test. Students receive college and career planning supports, as well as post high school supports for attaining the highest degree of training and educational achievement for the maritime field in which they choose. Supports include mentorship, counseling, scholarships, and ongoing opportunities to maintain their connection to the greater ohana wa`a.

He Waa He Moku He Moku He Waa is a voyaging sustainability program that utilizes farming as a method to produce the traditional canoe plants necessary for use in perpetuating voyaging practices.
