Assist landowners and operations to plan & implement natural resources conservation measures. Such measures include technical advice, cost-share, follow-up and monitoring. Primary areas of concentration are soil, air, and water quality; animal and plant nutrient management; grazing lands management; wetlands conservation; and wildlife habitat. Staff assisted producers in developing resource management plans and monitoring these plans. Wetlands were created, restored or expanded with accompanying acres receiving grazing management planning. Grazing management technical assistance was provided to producers, more interested individuals learned about grassland birds through a bird tour and producers participated in a three-day grazing school to learn more about grazing management techniques. Soil health demonstrations and educational programs were developed and presented to wide range of individuals and groups. Producers participated in a three-day soil health school to learn about soil health and applicable conservation practices. Residents of targeted watersheds received information, technical advice and cost-share in order to address water quality impairments, soil health, and conservation stewardship initiatives.

4b (Code:) (Expenses \$ 407,223 including grants of \$ 4,986) (Revenue \$ 413,499)

Cooperated with the State of South Dakota and three conservation districts to address a mountain pine beetle infestation in the Black Hills. Staff marked, with paint, those trees infested by the beetle and that should be removed. Producers were then eligible for State cost-share programs to assist them in removing the trees. Staff also worked in Custer State Park paint-marking trees that the State then contracted with others to remove. Most of this project's staff were seasonal but one remained year-round to assist the State in follow-up on those involved in the tree-removal cost-share program.

4c (Code:) (Expenses \$ 21,328 including grants of \$ 2,167) (Revenue \$ 12,790)

Educate the public and Association members on natural resources conservation issues and available programs. The Association sponsored or co-sponsored several education events. Multiple leadership development sessions for conservation district officials and staff were conducted. The Association assisted SD Envirothon to incorporate environmental education activities in education. The Association cooperated with the South Dakota State University Ag-Bio Proxy Council to raise awareness of agriculture and natural resources stewardship through their Ag Day activities on campus. In cooperation with governmental and non-governmental partners, education efforts continued to increase on the importance of healthy soils for production and sustainability. The Association cooperated with the Sand County Foundation and state sponsors of the Leopold Conservation Award to provide Leopold award winners opportunities to share their stewardship story. The Association continued their involvement in raising awareness of renewable energy issues, opportunities and challenges. The Association also continued their commitment to tree research through a project with Beadle Conservation District.

Part I-A, line 1: The State of South Dakota requires anyone representing an organization to register as a lobbyist in order to speak on behalf of the organization before a legislative committee. The Association registered the executive director and the president of the board of directors as lobbyists so that they might appear before legislative committees on behalf of the Association and its members. During the legislative session, the primary activity of the Association was to monitor legislative activities and report on a weekly basis to the Association's membership. This report took the form of an e-mail sent to each conservation district office and the Association's board of directors. It is a concise report of selected legislation that might be of interest to the members and did not usually encourage or solicit action by the conservation districts. The Association's registered lobbyists provided limited testimony (less than fifteen times) to legislative

committees; this testimony was to normally provide technical information or to update the committees on the activities of the conservation districts in assisting with the programs the committee had jurisdiction over.

Nationally, the Association kept members informed on possible and pending legislation and rules and how they might affect the conservation districts' activities. Information received from various groups was usually forwarded to the conservation district's e-mail accounts via the Internet. In some instances, the Association may include a brief analysis of the information. The Association encouraged its members to stay informed on political issues and become engaged, as the member deemed appropriate, in the discussion. The Association's executive director has some contact in the form of e-mail and phone calls, with the Congressional offices, primarily at the initiation of the Congressional staff.

The Association incurred few expenses in the activity since internet access is readily available for general activities. \$80.00 was paid to the Secretary of State for two lobbyist registrations. Staff time was estimated at one hour per week when the SD Legislature was not in session (43 weeks) and 12 hours per week during SD Legislature session (8 weeks) for a total of 161 hours and estimated value of \$5,738 at \$38/hour.
