Pottawattamie County has a lower graduation rate (88%) than Mills County (93%), and those over the age of 25 who hold a bachelor's degree or higher are comparable across Pottawattamie and Mills, however both Counties falling below the State, (62%, 62% and 69% respectively). Poverty rates in Pottawattamie County and Mills County are comparable or lower than state, (12.3%, 9.7% and 12.2% respectively), although the City of Council Bluffs has a higher rate of those living in poverty at 16.2%. Child poverty rates in Pottawattamie County are significantly higher than Mills County and the State of Iowa (17.5%, 12.7% and 15.5% respectively). Data at the city level (Council Bluffs) was difficult to acquire in all indicators, however Council Bluffs has approximately 12% of its families living in poverty compared to 11.5% in the United States overall. Median household income is at \$51,939 for Pottawattamie County, but drops to \$45,204 for the City of Council Bluffs. Income is considerably higher for Mills County with \$65,160 being the median household income. The State of Iowa median household income is at \$52,716. Unemployment is even with the State of Iowa for both Pottawattamie and Mills, with rates being at 4.2%, 4.3% and 4.3% respectively. Uninsured rates are slightly higher in Pottawattamie County with 11% of the population not having insurance, Mills County is at 8% uninsured and Iowa overall is at 10%. The City of Council Bluffs is comparable to Mills County and the State of Iowa with 8.1% of the population without insurance. Aside from the City of Council Bluffs these two Counties are primarily rural, with large portions of agricultural land. Both Counties are situated along Interstate 20 and have access to Interstate 80 offering a strong transportation infrastructure. Gaming is also a primary industry in Council Bluffs with there being three hotel casinos that offer various forms of entertainment and gambling. From this industry grew the Iowa West Foundation which seeks proposals for funding around economic development and healthy families.</p>

Unlike subsidized areas such as burn units or behavioral-health services, Medicare is not a differentiating feature of tax-exempt health care organizations. In fact, for-profit hospitals focus on attracting patients with Medicare coverage, especially in the case of well-paid services that include cardiac and orthopedics. Significant effort and resources are devoted to ensuring that hospitals are reimbursed appropriately by the Medicare program. The Medicare Payment Advisory Commission (MedPAC), an independent Congressional agency, carefully studies Medicare payment and the access to care that Medicare beneficiaries receive. The commission recommends payment adjustments to Congress accordingly. Though Medicare losses are not included by Catholic hospitals as community benefit, the Catholic Health Association guidelines allow hospitals to count as community benefit some programs that specifically serve the Medicare population. All collection activities conducted by the Facility, a Designated Supplier, or its third-party collection agents will be in conformance with all federal and state laws governing debt collection practices. All third-party agreements governing collection and recovery activities must include a provision requiring compliance with the hospital facilities' financial assistance and billing and collections policy and indemnification for failures as a result of its noncompliance. Compensation of the senior most executives is reviewed annually.
