During year-end Form 990 preparation, the outside accountant discovered payments to contractors and money received during the year in the Educational Foundation account that related to the building improvements. These transactions should have occurred in the Alumni Foundations account. After making the treasurer and board aware of these transactions, management decided to request refunds from the contractors to fully refund the Educational Foundation and refund the previous transfers back to the Alumni Foundation, restoring the Educational Foundation funds to the level they had before the disbursements occurred. The Alumni Foundation will then pay the contractors to make them whole. To record these transactions in the current year, management has recorded a receivable from the contractors and a liability to the Alumni Foundation. The receivable and liability will be satisfied when the funds are moved in the fiscal year ending June 30, 2018.
