The Psych Respite program, formerly known as Mental Health Respite program, provides shelter and case management on a 24/7 basis to consumers experiencing a need for transition to another residential setting or a break from a current residential setting. The intent of the service is to support consumers throughout the transition or break, provide linkages to needed behavioral health services and assist in transition back into the community. During FY '16-'17, about 7 mostly indigent women benefited from services.
