The Yuma's Education Scholarship Fund board of directors reviews the application and awards scholarships based on financial need. Upon board approval, the scholarships are issued to the qualified private school in Arizona. The school is informed by letter that they may not receive an amount per student (from all tuition organizations) in excess of the total tuition amount due for each school year. In the event an excess amount is received by the school, then they are instructed to return the excess funds to the school tuition organization. The application is available on our website.
