Environmental Demand Response Research Program - This program involves WattTime directly conducting research and analysis of power grids, to develop software tools to calculate what times electricity is more or less environmentally friendly. (Sharing these tools with the public to enable the more environmentally friendly use of electricity then happens through our Education and Assistance programs.) In this 2017 half-year we continued to make significant research progress. Specifically, we: (1) adjusted our algorithms to account for significant growth in renewable energy in the U.S. in 2017, which is changing which specific times of day are the best for reducing environmental harm; (2) explored applications of environmental demand response to new technologies, including fuel cells and hydroelectric dams; and (3) expanded our field trials from 2016 to larger online surveys of whether most people prefer equipment which is equipped with environmental demand response capabilities.

4b (Code:) (Expenses \$ 99,369 including grants of \$) (Revenue \$ 0.)

Environmental Demand Response Education Program - This program involves spreading awareness of the potential to reduce environmental harm by shifting electricity use to particular times. (Enabling the public to act on that awareness happens through our Research and Assistance programs.) In this 2017 half-year we collaborated with the Rocky Mountain Institute to host the major industry workshop we spent much of 2016 preparing for, with 60 different manufacturers, utilities, large energy buyers and others who were interested in learning about environmental demand response. We also conducted a follow-up webinar and numerous educational phone meetings afterwards. We also supported several large industry associations, including the California Energy Storage Association and the American Water Works Association, in understanding how their member organizations could reduce their environmental impact through electricity timing.

4c (Code:) (Expenses \$ 26,572 including grants of \$ 0) (Revenue \$ 25,500.)

Environmental Demand Response Assistance Program - This program involves supporting the development and spread of protocols for shifting electricity use to environmentally friendly times. (Conducting research to help make such tools possible, and spreading awareness of such tools, happens through our Research and Education programs.) A particular focus on this 2017 half-year was applying the results of our research from 2016 into whether the widespread Greenhouse Gas Protocol could be adapted to help simplify the process for large buyers of electricity to measure the impacts of reducing pollution by shifting energy from one time to another. Our research concluded this was possible, and we worked extensively with large energy users, equipment manufacturers, and protocol developers (notably Verified Carbon Services and the World Resources Institute) to begin implementing that protocol update.
