Additionally, there has been a 439% increase in the number of middle and high school students participating in educational field experiences since 2013. Reached 54 teachers through 20-hour professional development opportunities that provided skills for facilitating outdoor learning with their students. 97% of teachers put their training into action by leading outdoor activities with their students. Provided funding for transportation and/or substitute teacher costs for 155 field trips and provided field equipment through our Resource Co-op lending library that was used by 3,680 students. Developed and launched a NatureHoods Education program for Kindergarten-2nd grade students that connected over 1,200 students to natural areas around their school. Implemented the second annual, Discover Nature Festival, which provided over 30 outdoor recreation, nature education, and health and wellness activities. The festival reached over 1,600 participants. Coordinated and funded an internship program in which 6 high school or college youth participated in paid intern experiences with Children's Forest partners. Provided a free after-school program, Kids On-the-Move, to 80 participants. The program engages elementary students in active outdoor activities in local parks, as an alternative to after-school screen time. Reached 574 participants through Discover Nature Days, which are free family programs in local parks that include hands-on science activities, arts and crafts, and active games. Reached 72 new parents through Tiny Explorers, a new program that provides outdoor meetups for new parents and their infants and free baby carriers to families that qualify for the Oregon Health Plan. Facilitated a training for 20 outdoor educators from several Central Oregon non-profits about working with students with disabilities. Launched Our Rivers, Our Forests, a new program for preschools that provides nature-based curriculum in their schoolyard or nearby natural areas. The High Desert ESD provides a service to CFCO, acting as the recipient and dispersal agent for federal and school district dollars that are used for CFCO programs and staff.
