FACILITATING COLLABORATIONHealthy local farms and gardens require healthy local soil. Food Well Alliance learned that local farms and gardens cannot produce enough compost and instead must purchase it from out of state. To address this challenge, we convened our first Composting Working Table. Food Well Alliance convened 50 local compost experts, entrepreneurs, educators, and advocates with the intention to catalyze community-based (not large-scale commercial) composting practices through information exchange and discussion of drivers and barriers to system and infrastructure development. From this meeting, we invited 20 committed leaders to join our Working Table. Through several working sessions, the Community-Based Composting Working Table developed a list of 63 challenges and nine priorities on which to focus. One of the priorities was accomplished when Food Well Alliance, with a grant from EPA, established the Atlanta Community Composting Council. In addition, Food Well Alliance created a Design Table, to tackle priorities around education and awareness for restaurant employees to improve feedstock for composting that comes from meal preparation. Also, the first Food Well Alliance White Paper, Closing the Loop, Food Waste in Atlanta, was published. It outlined the findings of the Working Table and received great coverage nationally on social media.

Form 990, Part III, Line 4b:

MOBILIZING CAPITALFood Well Alliance's grant program focused on supporting growers and markets that engage with local neighborhoods to build healthier communities together using sustainably grown, local food. We funded workshops attended by a diversity of growers to help them grow, safely package and sell their produce at farmers markets. The Food Innovation Fellowship, a six month capacity-building, professional development, and mentoring program, enabled fellows to receive intense, sometimes one on one training on crafting their business models, creating financial forecasts and learning how to tell their story. Graduation Night gave farmers, nonprofit leaders, and entrepreneurs an opportunity to pitch to a room full of investors and potential customers. Food Well Alliance provided its community gardens grant again this year to help gardens with infrastructure, volunteer engagement, neighborhood activities and other needs.

Form 990, Part III, Line 4c:

PROMOTING INNOVATIONEnsuring a healthy local food system requires our movement to understand its current and potential impacts. To address this challenge, we are developing Atlanta's first Local Food Baseline Report. This will lead to creating a Local Food Roadmap. The report will be launched at our Oct. 5 annual event. The report will include several case studies about the impact of a united local food movement in addition to the data we, and others have gathered. Most importantly, the Baseline Report asks the reader to engage in the data gathering process going forward to help continue the effort to create metrics that will help us point to successes, issues, and opportunities to make our local food movement more effective. Healthy Soil is an important part of the local food system and to continue to engage the community around healthy soil and waste recovery, Food Well Alliance held its annual Soil Festival where more than 325 people gathered to take workshops on composting, visited 17 exhibitors and enjoyed engaging with their community through sharing sustainably grown, local food.
