Inspiration Grants: Grants are awarded to schools in MCPASD to provide inspiring learning experiences for students and staff. This year applications were submitted by persons in ten district schools, with requests ranging from \$500 to \$2,000. Additionally, \$10,000 was awarded to establish makerspaces in each of the district's bricks-and-mortar schools. Applications were reviewed by a committee of foundation board members and awarded in May 2017.

4b (Code:) (Expenses \$ 5861 including grants of \$ 5861) (Revenue \$ -0-)

Supported Fundraising: The foundation also serves as a collection point for funds solicited by school groups that lack the means to easily raise funds on their own. Solicitations and uses of the funds must be in accordance with the foundation's stated mission. Services provided include collecting funds (use of deposit account and Paypal), invoicing, and disbursement (check writing, use of debit card, etc.). School groups must be operating under the auspices of the school district.

4c (Code:) (Expenses \$ 3000 including grants of \$ 3000) (Revenue \$ -0-)

Scholarships. These are awarded to graduating high school seniors to pursue post-secondary education. Application is open to any graduating senior from the two district high schools and the district-sponsored online school. Applications are reviewed by a community-based board chaired by one of Middleton High School's deans.
