It is characterized by advocacy, communication, and resource management and promotes customer accountability. Community collaborations are a necessity to the success of the customer. Over 200 partnerships have been established and are maintained by the community support staff. Over 4,000 individuals and families have received a service. Participants may be involved in the project for up to 24 months. In some situations the full amount of time may be needed due to the disability acceptance and confirmation of social security benefits, waiting periods for low-income or See Form 990, Page 2, Part III, Line 4a (continued)

4b (Code) (Expenses \$ 298,214. including grants of \$ 125,447.) (Revenue \$ 0.) Transitional Housing provides temporary housing for homeless individuals and families. During the transitional time, individuals are assisted with necessary services such as employment, disability or social security to secure income. Once gainfully employed or monthly income is established, individuals and families move to permanent safe and affordable housing. The agency maintains 17 low-income housing units.

Support Services are ancillary services such as transportation, food, nutritional support, dental and vision assistance and other services assisting individuals and families in reaching the goal of self-reliance.
