The Foundation funded 22 innovative teacher grants totaling \$52,847.73. These grants impact directly classroom teaching and learning. The grants covered a wide spectrum of classroom learning including: Alternative Seating: Providing Choice and Sensory Stimulation in the Kindergarten Classroom, Elementary Reading, Elementary Girls on the Run/Heart and Soul, Various Art Grants, Middle School Google Expedition Kits, High School ACT Preparation, Minority Leadership and College Planning, Anti-Bullying Touring Production, High School Mentoring Program, International Student Festival, Brain Development and Common Vocabulary, Layered Learning: Science, Social Studies, Math and Literacy, Boys Let Me Run Program, Constructing Quality Early Childhood Education, Impact Literacy, and BlockFest.

4b (Code:) (Expenses \$ \$10,042 including grants of \$ 10,042) (Revenue \$)Mainstreet Credit Union Pioneer Pride Character Program

The \$10,042 Pioneer Pride Character Program was started as a pilot in September 2010. This is a community-wide program with the goal to teach and reinforce integrity and character amongst students, staff and community members. The first Friday of each month a new character trait is introduced. In addition, teachers find teachable moments to reinforce the trait. The months' character traits are: August - Pride; September - Responsibility; October - Respect; November - Self-Control; December - Cooperation; January - Honesty; February - Integrity; March - Courage; April - Compassion; and May - Perseverance. Each school recognizes students, staff and community members who best epitomize the trait. Some schools have skills, assemblies, and special award to to emphasise the character traits. The program has been highly successful with students and staff with many community businesses and members embracing the program.

The \$8,715 grant for the annual Country Club Bank Horizon Scholar Gala honors students for their academic achievement, teachers for their commitment to excellence and parents for their continued support. To qualify as a Horizon Scholar, a student must be a senior who has shown outstanding academic performance by achieving a 4.0 or higher GPA. Scholars are honored along with the most influential teacher in their educational career. The evening is a celebration of teaching and learning.
