Transportation program offers residents assistance accessing healthcare, social service and other essential appointments, typically via volunteer drivers. Those eligible under this program include seniors, individuals with disabilities, families and other adults. Volunteer drivers drove 7,105 miles giving 1,450 rides in this fiscal year. Bus and gas certificates totaling \$1,980 were distributed to help 179 individuals and families with transportation needs identified under social service plans.
