The operating agreement states that the Director of the Museum shall also serve as the COO of the Foundation and the CFO of the Museum shall also serve as the CFO of the Foundation. However, these individuals will be considered employees of the Museum, not the Foundation. As part of a supplemental support agreement between the Foundation and the COO, the Foundation makes payments to the Museum for supplemental salary amounts which are paid by the Museum to the COO as part of his salary. These amounts totaled \$145,888 for the year. The salary supplement provided to the COO by the Foundation were included as taxable compensation in the COO's W-2 at the Museum. The operating agreement was amended effective February 1, 2016 with no changes to this arrangement.
