SCWIB provides workforce development opportunities and resources in an eight county region of south central Pennsylvania. The SCWIB oversees six Pa Careerlink Offices for job seekers and employers as defined in the Federal Workforce Innovative Opportunity Act. The SCWIB focuses on contracting with programs that enable employers, dislocated workers, EARN participants, unemployed individuals, and youth to attain the job skill competence required by employers.

The organization expended Federal Workforce Innovative Opportunity Act Title 1 and discretionary grant funds to enroll 1,227 adult, youth, and dislocated workers in job training and development services. Rapid Responses, core and intensive job search and development activities were provided for major layoffs in the eight county south central region of Pennsylvania. Eligible participants services included workshops, on-the-job training and skill specific training. Initial core service and eligibility determination and assessment occur at any of the six One Stop Centers (Careerlinks) within the eight county region in accordance with the WIOA Act. Program services fund Title 1 sub-contractors providing case management, individual skills training, tuition, and on-the-job reimbursement. Eligible participants served included: 309 in and out of school participants. Rapid response individuals impacted by major layoffs, adult and dislocated workers: 365 adult and dislocated workers received tuition based training or on-the-job training and rapid response events were held for employee layoffs under the WARN notifications. Youth placement rate is 65%, adult retention rate is 87%, and dislocated worker retention rate is 92%, all meeting Pa State performance goals. Careerlink costs amount to \$1,182,806. Youth DHS TANF enrolled 455 participants (youths) during program year July 1, 2016-June 30, 2017;

Federal and State grants awarded to subcontractors to enroll 718 welfare TANF adult participants and joint jobs initiative programs over the twelve month fiscal period. 47% or 338 participants claimed job placements of 20 or more hours per week. The measureable job retention rate was 55.1% of those placed who retained jobs for six months July 1, 2016 and thereafter. Work activities programs such as work experience for enrollees were funded thru this program
