The Budget and Finance committee may ask for input from the Chairman of the Investment Committee to help determine the appropriate spending policy recognizing that financial assets will fluctuate in value. The policy of the school has been and will continue to be to review the endowment spending rate periodically but to refrain from frequent changes in the spending rate that may appear or reflect responses to short-term market movements rather than to longer-term investment objectives. Beginning with the 2010/2011 fiscal year, Gilman School's endowment spending rate was 5% (up from blended rate of 4.3%). Currently, it is the School's policy to reduce the spending rate 0.1% every year until it reaches 4%.

Income which is not related to exempt purposes, less applicable deductions, may be subject to federal and state corporate income taxes. Accounting principles generally accepted in the United States of America provide consistent guidance for the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribe a threshold of "more likely than not" for recognition of tax positions taken or expected to be taken in a tax return. The School performed an evaluation of uncertain tax positions for the year ended June 30, 2017, and determined that there were no matters that would require recognition in the financial statements or which may have any effect on its tax-exempt status. As of June 30, 2017, the statute of limitations for fiscal years 2014 through 2017, remains open with the U.S. Federal jurisdiction or the various states and local jurisdictions in which the School files tax returns. It is the School's policy to recognize interest and/or penalties related to uncertain tax positions, if any, in income tax expense.
