Support is intended to highlight the importance of population health in nursing practice and education and to create opportunities for the advanced nursing practice community to collectively meet the challenges of improving the population's health. Grantees' expenditures and activities are monitored by program staff via the submission of quarterly and final project narrative reports. AACN distributes funding on behalf of the Jonas center for nursing and Veterans healthcare to institutions that were selected for the Jonas scholars program based on the application submitted. Institutions are responsible for selecting individual scholars who must sign and submit a signed scholar agreement form once selected. Scholars are required to submit a progress report every year providing an update on progress in their program, achievement of goals, and outline challenges and successes. In addition, scholars must also complete a formal leadership program. Institutions are required to submit financial reports which indicate how the scholarship money was spent on an annual basis. Part III. Johnson & Johnson scholarships. AACN distributes scholarship funds on an annual basis directly to the student. Scholars are required to submit progress reports twice annually for each year of funding. The report form includes status of academic progression, self-assessment of goal achievement, updates on leadership development activities, outline of plans for final months at the institution and a financial statement. Scholars are also required to submit a final report within three months of completing the graduate degree. Aftercollege scholarships, hurst scholarships, and castlebranch scholarships. aacn distributes scholarship funds to eligible nursing students on a one-time only basis. Scholarship applicants must complete an application form and essay for award consideration. Aacn staff determine if all eligibility requirements are met, select winners, and confirm application information before awards are finalized and announced. No student follow-up is conducted after scholarship monies are disbursed. Aacn distributes the fellowship stipend on a bi-monthly basis and reimburses for travel and training opportunities. Fellows are required to submit a scope of training outline at the start of their fellowship, serving as a guideline for the fellow and cdc mentor. Fellows are required to submit quarterly activity journals illustrating progress on assigned projects and professional development goals. Each journal is signed by the fellow and cdc mentor and submitted to aacn. Three weeks after fellowship completion, a final report is required to highlight accomplishments and provide cdc/aacn subjective evaluation of the fellow experience. Training evaluations are completed with assistance from the cdc mentor and are conducted as needed. AACN administers the National Institute on Drug Abuse (NIDA) Mentored Training Award. An advisory council selects the awardee and periodic progress reports are required. The awardee is responsible for a final project which is disseminated at an AACN meeting.
