The HOC Finance Division is responsible for the Agency's financial management, cash management, rent collection, accounts payable, budgeting, purchasing, and the oversight of the Agency's portfolio. All grant funds received from are received and distributed through HOC's Finance Division. HOC has extensive experience with grant-funded programs and has established procedures and systems with fully document expenses and account for the expenditure of funds. Funds are segregated and reports are generated based on documented expenditures. Staff costs are documented by payroll sheets signed by both the employee and the supervisor. The Public Fund Accounting Unit has the responsibility for the accounting and billing of any grant awarded by any federal, state or county agency. When a contract for a new grant is received, the Public Fund accounting unit with the specific program administrator set up financial statements and establishes mechanisms for recording, tracking, and billing based on the approved contract. It is the policy of HOC and HOCPC to maintain an internal control structure in order to ensure that assets are protected from loss, theft, or misuse, including the portion related to Federal financial assistance programs. HOC consistently ensures that adequate accounting data is compiled to allow for the preparation of financial statements in conformity with generally accepted accounting principles (GAAP). HOC's internal control structure is designed to provide reasonable, but not absolute, assurance that these objectives are met each year.
