As a result, the NRLCA immediately notified law enforcement authorities. The NRLCA also conducted an internal investigation and engaged an independent forensic accounting firm to perform its own investigation. Based on these investigations, it was determined that a total of \$221,514 had been embezzled. In July 2017, the employee pleaded guilty to the criminal charges and sentencing is scheduled for October 2017. The NRLCA had employee dishonesty insurance and has successfully recovered the \$221,514 of lost funds from its insurers. In May 2017, the NRLCA discovered that a part-time employee was fraudulently claiming, and being paid for, days of union service to the NRLCA when in fact she was also being paid for those days by the Postal Service. It was discovered that this occurred over several years and resulted in a loss to the NRLCA of \$10,207.29. The individual was immediately terminated from her NRLCA position and has entered into an agreement to make full restitution to the NRLCA by January 1, 2018. In addition, the employee has agreed not to seek or serve in any elected or appointed office of the NRLCA or any affiliate state association at the local, district, state, and national levels for a period of ten (10) years effective May 17, 2017.
