The League held more than 300 educational events in communities across the country to help people understand the new schemes and structures used to influence elections and erode protections against corruption in our political process, and to review possible responses to counter them in the current environment of rapid change. The League's VOTE411.org initiative helped more than 4 million voters in 2016 and 2017. Voters counted on the League and VOTE411.org to provide valuable information about the elections in their communities, including up-to-date information about polling places and requirements for voting, and information about opportunities to learn more about candidates such as by attending one of the hundreds of candidate debates and forums hosted by the League this year.
