Rental Properties CFH owns and manages 18 rental units to provide rental homes to the local workforce. CFH has owned 7 Community Benefit Units at The Grove at Arlington, VA since 2008. In addition, CFH owns and manages 2 Affordable Dwelling Units in Charleston Square in Fairfax, VA. Both the Arlington and Fairfax units are managed in accordance with each County's requirements. To increase the CFH rental portfolio, CFH built a duplex on Charles Street, Fredericksburg, VA and acquired 7 additional units on Airport Avenue in Fredericksburg, VA. All CFH units are rented to tenants with low-to-moderate incomes. CFH also continues to have a co-ownership interest in its first rental property of 30 units in Vienna, VA, known as Briarcliff. CFH provides permanent rental homes to approximately 165 adults and children annually.

Form 990, Part III, Line 4b:

Virginia Ely Senior Rental Assistance Program provides rental subsidies to seniors whose incomes do not exceed 30% of the area medium income and who qualify to live in Fairfax County, VA-owned senior facilities. This is a grant-funded program that allows eligible participants to use 40% of their incomes as rent; the program pays the balance of the rent. The incomes of the participants have income that range between \$8,600 and \$22,000. Each participant is required to apply for a permanent rental subsidy such as the Housing Choice Voucher Program when applications are being accepted. 49 senior households received rental assistance during fiscal year 2016.

Form 990, Part III, Line 4c:

The Neighborhood Stabilization Program (NSP) is a Federal Program that began in 2008 and is administered by local jurisdictions through sub-grantees. NSP was designed to re-stabilize communities in which the sub-grantees purchased foreclosed properties to be rehabbed and re-sold to income eligible buyers. The organization became an NSP approved sub-grantee in 2009 and has acquired 21 homes through Fiscal Year 2017, 20 have been sold, 1 is expected to be sold in early FY 2018. More than half the buyers have had incomes less than 50% area medium income. Nineteen of the 21 homes have been in Prince William County, the 20th home was in Spotsylvania and the 21st home was purchased in Strasburg, VA.

To date, CFH has created homeownership opportunities for 14 households.</p> <p>OTHER PROGRAM SERVICES 5 The Edie Streett Security Deposit Assistance Program provides security deposit assistance for households whose incomes do not exceed 50% of the area medium income and whose rent does not exceed half their monthly incomes. The organization has been providing security deposit assistance since 1988. During Fiscal Year 2017, CFH helped 25 households served consisting of 35 adults and 21 children.</p> <p>OTHER PROGRAM SERVICES 6 Choices Life Skills CFH provides comprehensive life skills training through the Choices program to enhance personal growth and basic life skills for the CFH tenants and the clients of the Program Partners. CFH provides information in classroom settings for participants and can train facilitators who would continue to train the Choices program to clients they serve. CFH continues to expand the marketing for this program and during the last fiscal year provided training for transitional housing programs, clients of the local drop-in center as well as residents of the local Adult Detention Center, clients of the VIEW Program and a local Permanent Supporting Housing program. Also trained additional classes of transitional housing residents and is in negotiation with other organizations to provide training to their clients. Expenses include the salary and benefits of the Life Skills Coordinator who is providing the marketing and training for Choices.</p> <p>OTHER PROGRAM SERVICES 7 Linton Hall Manor was developed to create homeownership opportunities in Bristow, VA. CFH developed 23 single family home lots and 19 town home affordable lots that were proffered to Prince William County, VA Police Officers, Fire and Rescue Techs, Municipal employees and school teachers. CFH was the developer on this project doing site work for all lots which were then sold to NV Homes to build the units. The homes were sold between 2007 and 2012. The bond released in early Fiscal Year 2017.</p>
