ENTREPRENEUR PROGRAM-CIT recognizes that the availability of early-stage capital is a critical need of many emerging technology companies by making connection with "hard to access" private and federal funding sources. CIT's Growth Acceleration Program (GAP) Funds make seed-stage equity investments in Virginia-based technology companies with a high potential for achieving rapid growth and generating significant economic return. CIT's federal funding assistance program (FFAP) identifies and accelerates opportunities for Virginia's small technology businesses to obtain SBIR, STTR and ATP awards and other government contracts. The GAP and FFAP are funded primarily by appropriation received from the Commonwealth of Virginia. Revenue of \$1,590,278 reported above is proceeds on liquidated investments and does not include appropriation from the Commonwealth of Virginia.

COMMONWEALTH RESEARCH COMMERCIALIZATION FUND (CRCF)- Through its granting program, the CRCF accelerates innovation and economic growth in Virginia by advancing solutions to important state, national, and international problems through technology research, development, and commercialization.

MACH37 Cybersecurity Accelerator-MACH37 is designed to facilitate the creation of the next generation of cybersecurity product companies. MACH37's unique program design places heavy emphasis on the validation of product ideas and the development of relationships that produce an initial customer base and investment capital. MACH37 is funded by appropriation received from the Commonwealth of Virginia and by sponsorship revenue. Revenue of \$695,172 reported above is sponsorship income and does not include appropriation from the Commonwealth of Virginia.
