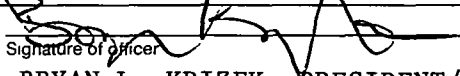

AHA IS DEDICATED TO POVERTY-STRICKEN FAMILIES, CHILDREN AND ELDERLY OR DISABLED ADULTS TO MEET THEIR EMERGENCY NEEDS AND STRENGTHEN THEIR EFFORTS TO BE SELF-SUFFICIENT, ESPECIALLY IN APPALACHIA.

FOOD AND BASIC NEEDS PROGRAMS - TARGET THE EMERGENCY NEEDS OF SEVERLY POVERTY-STRICKEN FAMILIES AND INDIVIDUALS IN RURAL APPALACHIA. BASIC NEEDS, SUCH AS FOOD, NEW SHOES, COATS, BLANKETS, HYGIENE ITEMS, UTILITY AND RENT ASSISTANCE ARE PROVIDED TO FAMILIES, DISABLED, AND ELDERLY WHO ARE LACKING DUE TO THEIR ECONOMIC AND PHYSICAL LIMITATIONS. AHA ALSO PROVIDES SCHOOL SUPPLIES, AND SUMMER LUNCH PROGRAMS FOR CHILDREN. THE HIGH LEVEL OF UNEMPLOYMENT AND POVERTY THAT EXISTS IN THESE RURAL AREAS COMBINED WITH FEW LOCAL RESOURCES CREATES A TREMENDOUS NEED FOR THIS TYPE OF ASSISTANCE.
THIS YEAR, AHA DONATED 31,534 LBS OF TURKEYS FOR THANKSGIVING AND CHRISTMAS AND 4,339 INDIVIDUALS BENEFITED FROM THE FOOD BANK SUPPORT. AHA PROVIDED 3,233 NEW COATS, 1,968 BLANKETS, 6,250 BACKPACKS CONTAINING SCHOOL SUPPLIES FOR ELEMENTARY AND JUNIOR HIGH STUDENTS, 17,752 DIAPERS, 2,558 PAIRS OF NEW SHOES, AND 1,740 BOXES OF LAUNDRY DETERGENT TO COMMUNITIES IN GEORGIA, KENTUCKY, OHIO, TENNESSEE, WEST VIRGINIA, VIRGINIA, MARYLAND, PENNSYLVANIA, NEW YORK, NORTH CAROLINA, INDIANA, ARKANSAS, ALABAMA, FLORIDA, MISSISSIPPI, AND ARIZONA. THESE ITEMS BENEFITED MORE THAN 20,000 INDIVIDUALS.

YOUTH DEVELOPMENT PROGRAM - WHILE SUMMER TIME MEANS NO SCHOOL, IT ALSO MEANS NO FREE SCHOOL BREAKFASTS OR LUNCHES AND NO STRUCTURED ACTIVITIES AND LEARNING. FOR MANY CHILDREN IN APPALACHIA; IT ALSO MEANS A SIGNIFICANT AMOUNT OF TIME SPENT UNSUPERVISED, WITH VALUABLE ENRICHMENT OPPORTUNITIES LOST AND A LACK OF NUTRITIOUS MEALS DURING THE DAY. AHA'S SUMMER CAMP PROGRAMS PROVIDED A HEALTHY, EDUCATIONAL, TROUBLE-FREE OUTLET FOR 231 CHILDREN TO ATTEND CAMPS IN KENTUCKY, GEORGIA, TENNESSEE AND WEST VIRGINIA. MANY OF THESE CHILDREN ARE FROM VERY LOW-INCOME FAMILIES ON A FIXED INCOME WHO WITHOUT THE ASSISTANCE OF AHA'S SUMMER CAMPS, WOULD BE LEFT WITHOUT POSITIVE AND WHOLESOME ACTIVITIES TO PARTICIPATE IN DURING THE SUMMER. AHA PROVIDED \$7,000 IN CASH GRANTS TO AID CHILDREN ESCAPING THEIR WORLD OF POVERTY BY MAKING SURE THEIR SUMMER CAMP EXPERIENCE OFFERED COMMITTED MENTORS, EDUCATIONAL OPPORTUNITIES, AND HEALTHY MEALS DURING THE SUMMER MONTHS.

HOUSING/SHELTER PROGRAM - A HOME WITH MORE PEOPLE THAN ROOMS AND NO INDOOR PLUMBING IS CLASSIFIED AS SUBSTANDARD. AHA HAS DEVELOPED A VARIETY OF PROGRAMS WORKING WITH LOCAL RESIDENTS IN COLLABORATION WITH CHURCHES AND LOCAL PUBLIC AND NON-PROFIT AGENCIES TO ADDRESS SOME OF THE MOST CRITICAL HOUSING NEEDS FACED BY APPALACHIAN COMMUNITIES. POVERTY IN APPALACHIA HAS PERSISTED THROUGHOUT THE NATION'S ECONOMIC BOOM FOR YEARS. UNEMPLOYMENT REMAINS THE HIGHEST IN THE COUNTRY, WHERE ILLNESS AND MALNUTRITION IS THE MOST PERVASIVE, TOO MANY CHILDREN LIVE IN RUN DOWN HOMES, OFTEN WITHOUT HEAT AND LITTLE NUTRITIOUS FOOD TO EAT.
