The network consists of the Cabin Creek Health Center located in Dawes, the Riverside Health Center located on the campus of Riverside High School which also serves as a school based health center, the Clendenin Health Center located in Clendenin, the Sissonville Health Center located in Sissonville, and the Kanawha City Health Center located in Charleston. Each of these health centers is operational five days a week. In addition CCHC operates part time school based health centers at the Sissonville, Herbert Hoover, and Riverside High Schools and East Bank Middle School. The communities served by CCHC have some of the highest rates in the nation of adult and child poverty and chronic medical conditions, including diabetes, chronic pain, COPD, obesity, and heart disease. West Virginia has the highest rate of disability in the country and southern WV is higher than the rest of the state. WV also has among the highest rates of the nation for behavioral risk factors, e.g. tobacco use, lack of physical activity, and poor nutrition. CCHC cares for a high number of patients with complex poorly controlled health problems along with high rates of behavioral risk.
