During the 2016 - 2017 academic year The Francis Center for Servant Leadership hosted a wide variety of civic engagement programs that placed students in volunteer roles alongside community members and local non-profits in the issue areas of hunger, homelessness, at-risk youth programming, support for people with disabilities and elder care In the 2016 - 2017 we continued all programs from the previous academic year, however, we utilized the volunteer efforts of 210 students, faculty, staff, and community members to expand our Hunger Relief Garden, which yielded a total of 550 lbs of produce during this fiscal year Produce was donated to local hunger relief agencies and distributed to neighbors in need We also began work on the garden to make it handicapped accessible so that people of all skill and ability levels can participate in meaningful volunteer work Through our partnership with Habitat for Humanity, 45 students, faculty, and staff worked alongside community volunteers to build homes for local families in need We assisted in the construction of two houses and also served hours in the Habitat ReStore We also began work on creating an official campus chapter of Habitat for Humanity Through our collaborative partnership with Stanly Community Christian Ministries (SCCM) and their Angel Tree program, the Pfeiffer community sponsored christmas gifts for 85 children from local low-income families We also worked alongside SCCM and the YMCA to serve meals to over 550 low-income residents of Stanly County at the Community Table in Albemarle Through academic service learning programs, Pfeiffer University engaged with the community while giving students the opportunity to increase their knowledge of community issues The College of Education provided student teachers and tutors to local Title-1 underserved schools, while also hosting a variety of extra-curricular events for children in our community including World Health Day, STEM Afterschool and Summer Camp Programs, and Night at the Library Over 250 local children were served through these programs The Masters in Marriage and Family Therapy program continued their free and low-cost counseling services for families in Charlotte and Raleigh, and our Religion Department placed students in practical theology internships serving local rural churches
