The organization builds and sells homes to families in need. Construction and the sale of 14 homes were completed during the fiscal year ending June 30, 2017. Twenty-one adults and 28 children were served. Of these homes, 12 were headed by females and 2 homes were headed by a Hispanic. One home (7%) of families was below 50% of the area median income and 93% (13) homes of families were below 70% of the area median income. One home (7%) was under 80% of the area median income. One home had disabled family members, seven families included African-American members, and two families were of Hispanic descent. 12 homes were headed by a single parent.

The organization also preserved existing homes through the repair of 46 homes, including the homes of 5 veterans, 3 disabled, 37 elderly and 28 headed by females. Seven households were below 25% of the area median income. Twenty-five households were between 25%-50% of the area median income. Fourteen households were between 50%-70% of the area median income.

Work in progress at June 30, 2017 included 7 home repair projects and 8 new construction homes.

For the fiscal year ended June 30, 2017, 3,370 volunteers donated 64,180 hours of time.

After committee review, a copy of the return is sent to Members of the Board of Directors for their review before filing.

Form 990, Part VI, Section B, Line 12c-Each year when the financial audit is conducted, the Finance Director inquires of all officers, directors, trustees and key employees whether any conflict of interest have occurred. Additionally, vendor and donor lists are reviewed to ascertain whether unreported conflicts of interest may exist. Potential conflicts are examined to determine whether these violate the Organization's policy.

Form 990, Part VI, Line 15a and b-The Organization has a compensation plan which establishes pay ranges for various classes of employees. Annually, compensation for all employees is reviewed by the executive management team. Raises are generally awarded based on cost of living, but department heads are allowed to spread raises, unevenly through their department based upon merit, within strict limits. The compensation of the Executive Director is included in the compensation plan and the annual review. Wage and salary increases are presented in total and by department to the Board of Directors for approval along with the annual budget. Periodically, the compensation plan is tested against information from a regional service bureau to ensure that wages and salaries are reasonable for the Western North Carolina region. A report of this test is reviewed by the Board of Directors and was last made during the year ending June 30, 2007. The organization has formed a Human Resources Committee of the Board of Directors which will be evaluating the compensation plan periodically to ensure that wages and salaries are reasonable for the Western North Carolina region.
