provide mental health care through 2 primary initiatives: implementation
of the NBCC Mental Health Facilitator program, and training and technical
assistance in implementing counseling services. This year, a capacity
building grant program was added to expand services available to veterans
in Colorado Springs, CO. To date, the NBCC Foundation has supported the
implementation of the Mental Health Facilitator program in DeKalb County,
Georgia, Jacksonville, Florida as well as several countries, and ongoing to
support to the programs in Bhutan, Haiti, Malawi, Mexico, Tanzania, Uganda
and Zambia; has provided counseling education materials free of charge to

The Foundation administers the programmatic deliverables for the
NBCC Minority Fellowship Program, through which twenty-three
doctoral students in counseling received \$20,000 education awards,
up to 30 master's mental health counseling students received \$8,000
and 49 master's substance abuse counseling students receive up to
\$14,000. The Foundation provides training assistance, mentors and
networking opportunities to enable them to successfully complete
their programs, and take leadership roles in reducing the disparities in
mental health care for minority populations.

Annually, the Foundation awards scholarships to individuals who are
pursuing careers in professional counseling, and who commit to serving
those in rural and/or minority communities for 2 years post graduation.
