North Carolina Pre-Kindergarten (NC Pre-K) - A high quality pre-kindergarten program that serves children who are at risk and prepares them for success in school. Pre-kindergarten is a research-proven strategy for school readiness and provides educated teachers, small class sizes, low teacher-child ratios, research-based comprehensive curricula, and a focus on the whole child and family. 610 children were served during the year.

4b (Code:) (Expenses \$ 330,809 including grants of \$ 3,495) (Revenue \$ 18,329)
Child Care Resource and Referral (CCR&R) program promotes quality child care and ensures that children acquire the skills to succeed in kindergarten. This program provides services to ensure that safe, high-quality, affordable child care is available, comprehensive consumer information on child care choices, parent support and training, capacity building, technical assistance, trainings, professional development, and provider recognition and accomplishments. During the year, the achievements of this program include the following: 147 trainings provided to child care providers, 403 providers trained and 94% of providers exhibited an increase in knowledge based on pre and post-test scores, 13 facilities received on-site technical assistance to increase their star rating, 35 facilities received technical assistance to maintain their star rating, 868 instances of technical assistance were provided to child care professionals with 648 being intense technical assistance.

The READ Wayne program delivers early reading initiatives to children in Wayne County ages birth to five, their families, and caregivers. This initiative is led by parent educators, focuses on specific pre-literacy skills and includes educational experiences for parents, caregivers, and community members. Additional elements include the delivery of high quality literacy experiences to children. 34 parent workshops were provided serving 324 parents in the community. 1496 storytelling sessions were provided and 236 professionals completed staff and community workshops.
