K to College programs - The Center's K to College programs (Pioneer Scholars, Scholars to College, and Scholars on Campus) propel academically-focused, low-income K-12 students and graduates towards success in college. The Pioneer Scholars program ensures that our elementary and middle school students are building academic skills, achieving in school, and laying the foundation for future college success. This year, each of our 80 Pioneer Scholars students participated in up to 865 hours of structured tutoring, enrichment, and leadership programming at the Center. The Scholars to College program ensures that high school students challenge themselves academically and personally, becoming graduating seniors who are scholarship-eligible and college-ready. This year, 122 Scholars to College students participated in an average of 5.75 hours of weekly curriculum-based instruction, individualized advising, tutoring, ACT preparation, and other enrichment activities at the Center. The Scholars on Campus program ensures that students successfully transition to higher education by supporting their academic and campus engagement, career planning, and financial responsibility. This year, 24 Scholars on Campus students participated in workshops, individualized advising, one-on-one campus visits, and a weekend retreat. Student progress is evaluated across all three programs using qualitative and quantitative assessment. The following results from the 2016-17 academic year highlight just some of our student successes: 100% of students increased their ACT Aspire score in at least one subject, 81% of our students are on-track in English and 99% are on-track in Math compared to 71% and 41% of their peers respectively. The 30 students in Scholars to College class of 2017 earned 171 acceptances to 69 different colleges and universities, and \$10.7 MILLION in scholarships and grants. Twenty students received full-tuition scholarships. 100% of Scholars on Campus students are on-track to graduate in 4 years or less, compared to 40% of all college students and 10% of their low-income peers.

Form 990, Part III, Line 4b:

Game Plan College - The Game Plan College program provides information and advice to Durham high school students, ensuring that they have the knowledge and support necessary to apply and enroll in college. The goal of the program is to increase the college enrollment and success rates of low-income students in Durham, ultimately changing the long-term economic outcomes for these students and their families. The program was developed in early 2016 and was piloted beginning in the fall and provides workshops and advising delivered by educators and peer Teen Advisors. In its first full year of operation, Game Plan College registered nearly 800 students and served 288 students in workshops and/or college advising sessions.

Form 990, Part III, Line 4c:

Facility Partnerships - In addition to college access programming, the Center enhances the impact of local organizations through Facility Partnerships by serving as a home and resource for nonprofits, schools, and community groups as they convene, learn, and grow. This year, 60 Facility Partners ran programs, hosted events, and held meetings at the Center, serving more than 1,200 students and community members in an average week. The Center provided space for free to over 90% of these partners, resulting in significant rental savings for these organizations.
