Program registration is taken at the Rock Hill School District's ParentSmart Resource Center. York School District's Family Resource Center also takes applications. York County Law Enforcement Center in York distributed toys to families in York. A total of 700 families were served including more than 2,000 children who received gifts through this collaboration. UWYC also serves as fiscal agent for Toys for Happiness and Empty Stocking Fund as described below. Toys for Happiness (TFH): WHRI Radio began this holiday assistance program in 1985 to collect toys for York County families in need. UWYC partnered with Toys for Happiness in 1992 to manage the toy warehouse, volunteers and provide toy distribution to families who qualify for assistance. Cash donations to the TFH program are utilized to purchase toys and gifts when the community toy drive is not sufficient to meet needs. Many community partners hold special events to collect bikes, toys and other gifts. Empty Stocking Fund (ESF): Established and promoted by The Herald for more than 30 years, this program provides financial resources to ensure assistance is provided to those in need during the holiday season. In 2008, UWYC was chosen to administer the Empty Stocking Fund to provide holiday assistance to children and families in need. ESF donations are used to purchase toys and gifts when the community toy drive is not sufficient to meet needs. Project Connect: Project Connect is a one-day event connecting homeless and low-income families to vital community services. Initiated in 2008 by The Regional Chamber of Commerce's Leadership York County class, the event sought to assist York County residents who needed basic social services. UWYC continues to support this event and partners with the City of Rock Hill and Weed and Seed Urban Rock Hill. On April 22, 2017, Project Connect was held at the Emmett Scott Recreation Center. We had more than 258 attendees, gave out 179 bags of free groceries, provided free haircuts and gave

Information regarding transportation services, housing, education, and job/employment was also provided. The Warming Center, established in 2007 as a collaborative venture with York County Council, UWYC administers several grants to provide security services and shelter management for homeless men during winter months when other year-round shelter providers are full. Key partners include Bethel United Methodist Church, UWYC and many volunteers. This year, Park Baptist Church joined efforts to provide additional shelter for overflow of men needing care. A total of 114 unduplicated men were provided winter shelter during November 2016 through March 2017. Each night the shelters were open, the men received a meal, a bed to sleep in, and access to showers and bathroom facilities. We worked with local agencies to place the men in existing programs that will address their long-term needs as space becomes available in appropriate programs in our community. United Way's Call Center 2-1-1: In September 2007, UWYC established this county-wide, federally-designated calling code to provide local residents access to comprehensive information and referral for health and human services. United Way's Call 2-1-1 is staffed 24/7, is an easy to remember number, confidential and free service accessible from both cell and land line telephones in York County. Callers are connected to our accredited call center in Columbia, SC, administered by the United Way Association of South Carolina. Certified call specialists make appropriate referrals to all area service providers in York County. In 2016-2017, more than 4,649 calls were received and more than 3,752 community needs were identified and referred to appropriate agencies and organizations. Utility assistance was the most requested need. In addition to community referrals, the 2-1-1 call center has contracts with DHEC and DSS and other providers to provide direct links for clients needing access to Medicaid sign-up and check status of requests, Affordable Care and Benefits search, SNAP (food stamps), and Women, Infants and Children (WIC) Program. In 2016-17 more than 49,194 referrals were made to these services for York County citizens. Childcare Initiative: UWYC participated in the United Way Association of South Carolina and Department of Social Services partnership to leverage additional federal funding to support local child care programs. For a United Way to participate in the program, support must be allocated to an agency's program that provides children's services. UWYC supports the following agencies that meet the criteria: Boys and Girls Clubs of York County and the Upper Palmetto YMCA. The UWYC's board approved \$66,100 in support of the

The Emergency Food and Shelter National Board Program (EFSP) is a federal program administered by the US Department of Homeland Security's Federal Emergency Management Agency (FEMA) and has been entrusted through the McKinney-Vento Homeless Assistance Act (PL 100-77) to supplement and expand ongoing efforts to provide shelter, food and supportive services for the nation's hungry and homeless, and people in economic crisis. The National Board selected United Way Worldwide to once again serve as Secretariat and Fiscal Agent to the National Board. In addition to representatives of National Board organizations, the authorization as revised (PL 102-550) in 1992 requires that a homeless or formerly homeless person be a member of each EFSP Local Board. York County is a funded jurisdiction under Phase 33 and was awarded \$124,750. The UWYC is responsible for managing a local EFSP board whose role is to advertise the availability of funds, establish priorities among community needs, allocation of funds to non-profit and government emergency food and shelter agencies and help monitor program compliance. UWYC provides staffing for administration of the York County jurisdiction, and maintains a shared client database to prevent duplication of service. Local recipient organizations are: Clover Area Assistance Center and The Salvation Army. Letter Carriers Stamp Out Hunger Food Drive. Each year York County community residents participate in the annual Stamp Out Hunger Food Drive. UWYC partners with the National Association of Letter Carriers through our local post offices and coordinates with food banks that need their shelves restocked during critical summer months. Residents are encouraged to leave non-perishable food items by their mailbox for local mail carriers to pick-up. On May 13, 2017, approximately 25,000 pounds of food was collected. In York County, participating pantries that received food items were: The Salvation Army, Clover Area Assistance Center, Fort Mill Care Center, Love & Cherish, Project Hope, P A T H, Pilgrims Inn and, Dorothy Day Soup Kitchen. Volunteer Income Tax Assistance Program. The Volunteer Income Tax Assistance (VITA) program offers free tax help to people who generally make \$54,000 or less, persons with disabilities, the elderly, and limited English speaking taxpayers who need assistance in preparing their own tax returns. In addition to providing free tax preparation, VITA works to ensure everyone in the community receives all of the tax credits and deductions for which they are eligible, especially Earned Income Tax Credit, Child Tax Credit, Education Tax Credits and Child Care Tax deductions. IRS-certified volunteers provide free basic income tax return preparation with electronic filing to qualified individuals. UWYC assists by promoting this service annually.
