The Club's Form 990 is prepared by the organization's CPA. It is then reviewed by the Club's treasurer and finance committee. The executive director signs the return.

Form 990, Part VI, Section B, Line 12c:

The Club's board of directors and its executive director sign the conflict of interest statement annually.

Form 990, Part VI, Section C, Line 19:

The Club makes its governing documents and Form 990 available to the general public upon request.
