For the 2016 - 2017 school year Pace had an enrollment of 1,105 students in pre-first through 12th grades. The student teacher ratio was 9:1 with a class size on average of 12 students. The faculty average years of experience is 17, with an average of 10 years at Pace Academy. The average ACT score of Pace students was approximately 30, 9 points above the national average. Curricular, co-curricular and hands-on activities, a scholar-in-residence program, leadership fellowships, internships and study tours support education around these themes. In 2016 - 2017 the ICGL study tours consisted of approximately 15 trips, and approximately 200 students traveled to countries throughout the world, including North America, South America, Europe, Africa, Asia and Australia.
