The mission of the Erlanger Health System Foundations is to enhance the health and wellness of all children and adults in the region by advancing medical excellence in collaboration with visionary partners. This encompasses our purpose of partnering philanthropic supporters with the world class nurses, physicians and staff caring for those in our community and region each and every day. This partnership is a great example of our not-for-profit community bond of receiving support from the community to fulfill our promise of helping anyone who needs us, regardless of their ability to pay, with the best treatments, latest equipment, and most well-trained physicians, nurses and staff. Together, we transform tomorrow through our combined work today. It is of utmost importance to us that we bring together the direction of the health system with the passions of our supporters in an aligned manner. Through this, we advance the priority areas of care endorsed by leadership and the physician experts while allowing donors to direct their contributions to impact the area of which they are most passionate. Through the use of various department specific restricted funds, our donors are able to direct their giving as they desire to help with selected areas of the health system. Undesignated gifts help with the greatest needs in both the adult and pediatric areas of care as directed by health system and physician leadership. All of these gifts are utilized both with donor intent and system aligned initiatives to further the care, education and research missions of the Erlanger Health System being taken into consideration. These gifts truly fuel the advancement of care in Chattanooga and the surrounding region by providing critical support for programs, capital equipment and infrastructure throughout the system. Because of the great outpouring of support from the community, the Erlanger Health System Foundations have had tremendous impact through giving - Funded a new, digital biplane cardiac catheterization lab for children and adults. This advanced biplane laboratory allows for two simultaneous images to be taken during procedures, which allows for enhanced vision for the physician, more efficient care and limits the amount of contrast dye received by the patient for proper imaging. All of these advancements lessen the impact on the patient during these critical procedures and enhance the capabilities of our highly trained physicians - Supported programs that enhance the pediatric differential in our Children's Hospital. Kids are not just small adults and require a completely unique and specifically designed culture of care that includes support systems like Child Life Specialists, playrooms, art and music programs and provide pediatric-designed equipment and facilities so that the unique needs of their growing bodies can be taken into consideration while performing even basic procedures like setting a broken bone and complex surgeries like closing a diaphragmatic hernia in a newborn. The support from the community helps provide for the additional expense associated with providing care customized just for children in every sense - Created and supported an annual educational lecture series on incorporating humanitarian values in medicine through an endowed gift by a local family with a history of service at Erlanger both professionally and through volunteering - Supported the Pastoral Care Pilot Initiative Program which allows for two full-time chaplains to work in three key areas of impact: clinical care, education and spirituality support with our patients, their families, and our staff - Advanced a variety of community health initiatives in both the adult and pediatric arenas of care. This includes programs such as the car seat clinics, injury prevention and safety programs, adult education on health related topics in the community, community cancer screenings, smoking cessation courses, and mobile care through pediatric telehealth in partnership with the Ronald McDonald House Charities Care Mobile Unit that helps provide better access to care to underserved communities using a "mobile clinic" that is staffed by Children's at Erlanger pediatric specialists - Funded key quality and safety initiatives to ensure that Erlanger is consistently enhancing services to adults and children to provide the latest forms of treatment with better outcomes and patient safety measures backed by clinically proven research, a best practice effort in healthcare. Since January of 2016, Erlanger Health System Foundations have been in a public campaign to fund the first phase of a new Children's Hospital. This campaign, named the Believe Campaign, is an effort to combine system funding of \$11.5M with philanthropic funding of \$28.5M to build the new Children's Hospital Outpatient Center at a total projected cost of \$40M. This effort is designed as a three year campaign and our results are ahead of schedule. With an enormously positive outpouring of support, Erlanger was able to break ground on this first phase facility on June 6, 2017, with plans to open it to patient care in December of 2018. To date, more than 4,600 different donors have contributed to this effort and we have raised a significant portion of the funding needed. The progress is on track to potentially complete the campaign a full year ahead of schedule with the continued generosity of this community and the surrounding region. This new facility will be state-of-the-art in both its kid-friendly designed environments and in its clinical efficiencies. Working in partnership with local community organizations, this facility will be unique to the Chattanooga region's history and culture and will be an anxiety-reducing, child engaging environment. This facility is the first of three planned phases to create world-class facilities to match our world-class physicians, nurses and staff. By far, this effort is the single most significant fundraising effort undertaken in our 126 year history but will deliver the single most important building this region has received in the past 25 years. This facility also marks an important moment for the adult services as well, as it will create new space and opportunities for additional enhancements of facilities for our adult population. The Believe Campaign and what it will directly deliver for kids, as well as make possible for adults, is the most transformational example in our history of our mission at work to enhance the health and wellness of all children and adults in the region by advancing medical excellence in collaboration with visionary partners.
