NBCC reviews and examines individual's credentials in order to attest to their qualifications to provide protection of the public and professional promotion and recertification of counselors. NBCC currently certifies over 63,000 counselors.

NBCC implements the SAMHSA funded Minority Fellowship Program for the counseling profession. During this reporting period, the program provided 23 doctoral students in counseling \$20,000 education awards, 30 master's mental health counseling students \$8000, and 49 master's substance abuse counseling students \$14,000. The program provides training assistance, mentors and networking opportunities to enable the students to successfully complete their degrees, and take leadership roles in reducing the disparities in mental health care for minority populations.
