The Faculty Endowment is to continue as long as its purpose can be serviced by its continuation and may otherwise be terminated or used for other purposes only upon a catastrophic occurrence that jeopardizes the existence of the School, as reasonably determined by an 85% majority vote of the Trustees.</p>
