Friends of Nazareth provided volunteers to assist the school to enrich and enlarge the school's ministry. The support included: 89
people to assist in providing four (4) summer camps for a total of 750 students. A day camp for preschool through 3rd graders was
conducted from August 3, 2017, to August 21, 2017. Three one week overnight camps were conducted from July 31, 2017
to August 18, 2017. Three team members assisted in leading the Leadership Development Course for 20 teachers and support staff.

4b (Code:) (Expenses \$ 39,604 including grants of \$ 38,000) (Revenue \$ 11,057)

A \$38,000 grant paid to the Nazareth Baptist School was provided to pay about half the costs of the four summer camps. This
grant was used to provide scholarships. In addition, the grant
helped expand the camp activities.

Friends of Nazareth provided two college-age interns who spent 7-10 weeks in Israel. The interns helped in the four summer camps.
When the interns were not involved in camps, they provided assistance to Serve Nazareth, a non-profit that operates the Nazareth
Hospital and at Nazareth Village.
