Now in its sixth year, ReadingPals is continuing to work to improve the reading skills of students in Gadsden, Leon, and Madison Counties. Last year, our ReadingPals volunteers read for 3,600 hours to over 200 students and gifted over 3,000 books!¹ As a result, more than 70% of our ReadingPals students achieved at least one year's worth of reading growth from Fall 2016 to Spring 2017. ReadingPals relies on hundreds of volunteers every year to read one-to-one with students who have been identified as struggling readers. Mentors are matched one-to-one with students in kindergarten, first, or second grades. Mentors report during the after school setting for one hour a week during the school year. Mentors choose the school and the day that best fit their schedule. Mentors utilize a curriculum created by LCS District and UWBB that is tailored to children's reading needs. Mentors present each student with a brand new book every week. Mentors receive training from UWBB and the school district (includes background screening).

Form 990, Part III, Line 4c:

In November 2014, United Way of the Big Bend was awarded the 21st Century Community Learning Centers (21st CCLC) grant. The grant awarded to United Way of the Big Bend covers four Title I schools, Apalachee Tapestry Magnet School of the Arts, Hartsfield Elementary School, Riley Elementary School and Ruediger Elementary School. This is a \$3 million grant over five years. During the 21st CCLC Program students have the opportunity to gain literacy and social skills through programs, and activities, such as youth development activities, drug and violence prevention programs, counseling programs, art, music, dance, drama, health and recreation programs, technology education programs, certifications and character education programs. The program is free of charge and snack or supper is provided to the students. The program begins in August and ends in May. The 21st CCLC Program follows the annual School District Calendar. School Sites are open during Early Release Days and closed during the districts scheduled Holidays and Teacher Planning Days.
