

Additional Information

The Twenty-first Century Council changed its name to the Lawrence County Higher Education Commission, with appropriate action with the Tennessee Secretary of State's office (see attached document). The organization is focusing its economic development and cultural development goals on the development of a new four year college campus Lawrence County in connection with Columbia State College, Middle TN State University and Tennessee Technological University. The directors believed that donors and potential donors would be more motivated to contribute to the organization if the name change was effected. The organization notified the Internal Revenue Service of the name change. The organization's FEIN remains the same.

Shortly after the above actions were taken, a new not-for-profit entity was formed under the laws of the State of Tennessee. This newly formed organization is named Lawrence County Economic Development Foundation (82-1479771) and was granted 501(c)(3) status by the Service in a letter dated July 13, 2017. The only asset of the Twenty-first Century Council was cash, which was transferred to the Lawrence County Economic Development Foundation. The Twenty-first Century Council was previously under control of the Lawrence County Chamber of Commerce. The Lawrence County Higher Education Commission is not under Control of the Lawrence County Chamber of Commerce, but the Lawrence County Economic Development Foundation is related to the Lawrence County Chamber of Commerce through board appointment.
