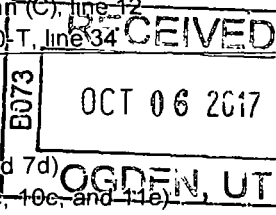

Core services include community partnership programs, studio program with tuition assistance for students in need, school touring program, and studio use program. Integral to the organization's mission is the community partnership program which serves more than 1,000 children at dozens of sites each week. These are students who are typical but very young, at risk, underserved, live in poverty, or who have special needs and challenges. Through dance, its community partnership program provides much needed opportunities for children to feed their imaginations, work together, explore big ideas, and strengthen their bodies and minds. Live music is an essential element to its curriculum for very young children and students with special needs.
