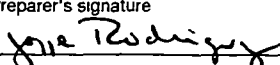

21st CENTURY COMMUNITY LEARNING CENTERS

21st CCLC is a comprehensive program covering educational, prevention, sports, recreational and art services. Its main objective is to improve academic progress, as well as technology skills of participants. During fiscal year 2016-2017 a total of 1,321 participants between the ages 6 and 18, and 225 parents benefited from the program. Services provided included tutorships, homework assistance, spanish and english classes, reading, character development, art, sports and recreational activities. Program results statistics were as follows:

- * 100% of participants attended services for 30 days or more
- * 804 (61%) participants finish school year with A or B grades in spanish courses
- * 562 (42%) participants increase their spanish course grade by at least 25 grading points
- * Approximately 99% of participants pass grade
- * Parents of participants took part of educational forums and employment opportunities forums, family time, time management and healthy styles workshops

PUERTO RICO PUBLIC HOUSING ADMINISTRATION (PROJECT LEARN PROGRAM)

Project Learn is a comprehensive program covering educational, prevention, sports, recreational, and art services. It impacted approximately 3,850 bonafide residents from different housing projects within ages 6 through 18, and 1,176 adults through its Family Support program. Activities supported included: Power Learning (747 participants), Empresarism (148 participants), Drug Prevention (676 participants), Leadership Program (208 participants), Performing Arts (612 participants), Sports and Recreation (1,476 participants) and Family Support (1,476 participants). These programs are carried out through different programs including Power Hour, Torch Club, Keystone Club, Goals for Graduation, Visual Arts, Dance and Theater, and Sports and Recreation. For fiscal year 2016-2017, 100% of the programmatic objectives presented to PRPHA were achieved. Major programs results were as follows: 87% of participants abstain from using alcohol, 98% of participants abstain from the use of tobacco and 96% of participants abstain from the use of marihuana. In the educational field, 99% of participants graduated from high school and 89% of those will continue post secondary studies.

TEMPORARY ASSISTANCE FOR NEEDING FAMILIES (TANF)

Program addressed to prevention services through SMART Moves module. Main objectives are to promote auto-sufficiency and promote strength of family relationships. Program directed to promote employment and encouragement of responsible maternity and paternity. During fiscal year 2016-2017, the program benefited 1,576 participants. Programmatic objectives were achieved 100%, and a Family Strengthening Conference were realized during the year.

Organization provides drug prevention and family support programs as well as mentoring through science and other subjects

* Mentoring and Leadership Program: Sponsored by OJP, is a prevention and mentorship program for youth in risk. Organization provided character and leadership development, educational and career development, and health and life skills. The program benefited 122 participants from different clubs, been able to follow up on each one of them individually, and 95% of participants were able to accomplish with the three components required by the program

* Alcohol Prevention: Sponsored by San Juan Municipality, program was directed to the prevention of sale and consumption of alcohol to minors. A total of 1,952 participants were reached by this initiative. 100% of programmatic objectives were achieved

* Prevention and Mentorship through Science: Sponsored by Sea Research Foundation, program was directed to the prevention and mentorship of youth through science. A total of 72 participants between 6 and 10 years old were reached by the program, and 81% of them attended at least 18 educational sessions.

* Volunteers Program. Program directed to capacitate volunteers through healthy habits activities. A total of 487 participants benefited from this initiative. 100% of programmatic objectives were achieved.

* Psicologic and Social Help for Crime Victims: Sponsored by OJP, the program provides a psico-social curriculum through arts to help crime victims. A total of 50 participants were impacted by the program. 100% of participants were able to identify and promote empathy aspects toward their peers.

* Sexual Education and Prevention of STD: Sponsored by PR Health Department, the program provides an educational curriculum for prevention of STD, to youth and their parents. A total of 50 youth participants and 16 parents were impacted by the program. The program achieved 100% of its programmatic objectives, and a total of 6 youth participants were able to document their learning experience through the "photo-voice" methodology.
