Eighteen students attending secondary school and three certificate students receive tuition and fees, room and board, supplies and transportation. Three students completed their secondary program and will begin certificate programs in Fall. The advanced level students participate in cost-sharing support. They include two students in diploma programs and one in a degree program at Gulu University.

Children UP provides students with the important service of mentoring. In-school mentors attend to student needs and issues arising within a particular school. Our staff serve as mentors to all our students addressing additional concerns and assuring tuition fees, supplies, transportation expenses are paid. They advocate for the students and foster communications with parents/guardians.

Children UP board strives to add an equal number of young men and women into our program.

The board requires that we have funds to support a student through six years of schooling before we invite a new beneficiary.

To be eligible for yearly renewal, all students must achieve strong grade results, be disciplined and maintain regular communication with mentors and coordinators.

In 2016 a branch of Children UP, Children UP Uganda, led by Director Okello Vincent was officially recognized by the Ugandan NGO Board.

Through presentations to our supporters and the general public, on our website, in e-newsletters, social media and personal communication, in USA, the students' educational experiences are illustrated and a view into their culture is offered.
