Monthly support groups were held for community members with chronic obstructive pulmonary disease. The Safe Sleep Program provided new cribs to any family in need and memory boxes to mothers who have lost their babies during pregnancy. Thirteen physicians gave community talks during the tax year. Mercy hosted the 6th annual coaching summit, offering educational programs and sessions to 500 area junior and senior high school coaches. Mercy is in its second year of offering an internal medicine residency program in partnership with University of Arkansas for Medical Sciences to increase the number of practicing primary care physicians in the area. The second class of eight residents began this year. 2. Behavioral Health: Mercy, in partnership with the Endeavor Foundation, completed the Join the Solution project, a one-year study assessing mental health services, physical health services, and distribution of basic needs to students in five major area school districts. Based on results obtained from this study, the Center for Collaborative Care, of which Mercy will be a key sponsor and supporter has been developed. This new entity will aim to address the needs identified in the study by use of community liaisons and a technology platform. Behavioral health services were expanded significantly to a total of 4 psychiatrists, 4 psychologists, 5 therapists, and 3 interns, expanding access and the departments ability to provide care to low-income patients. About 280 low income clients were seen for no charge by therapy interns in collaboration with supervising therapists. The physician mentoring program, RAPHA, is in its first year.
