DURING THE 2016 - 2017 SCHOOL YEAR, THE VOLUNTEER READING INITIATIVE OF THE UNITED WAY OF NORTHEAST LOUISIANA, READ LEARN SUCCEED, 313 COMMUNITY VOLUNTEERS READ WITH 164 STUDENTS IN THE 2ND AND 3RD GRADE IN 12 SCHOOLS IN OUR COMMUNITY FOR 1,906 READING HOURS, WHICH RESULTED IN AN INCREASE IN READING LEVELS OF 96% FOR MONROE CITY, OUACHITA PARISH, AND LINCOLN PARISH SCHOOLS. INCOME - THE FOCUS OF UNITED WAY IS ON HELPING HARDWORKING INDIVIDUALS AND FAMILIES BECOME MORE FINANCIALLY STABLE. OUR TARGET ISSUES ARE INCREASING INCOME, BUILDING SAVINGS, AND GAINING AND SUSTAINING ASSETS BY FOCUSING ON FINANCIAL EDUCATION FOR HIGH SCHOOL STUDENTS.
