Our programs include adult education and job assistance, emergency assistance (financial assistance, food pantry, free coffee house and advocacy), after-school youth recreation, and prison visitation.

Adult Education providing quality educational services to adults who have not yet attained their secondary diploma and to prepare them for post-secondary education and/or training programs, as well as employment. Over 150 adults enrolled in one of our basic education or GED preparation classes. Another 120 participated in one of our community education or employment preparation activities.

4b (Code:) (Expenses \$ 95,427 including grants of \$ 81,681) (Revenue \$ 00)

Emergency Assistance this program provided emergency financial assistance to individuals and families facing eviction, loss of utilities, deaths in the family, fees for needed services, etc. We prevented 72 evictions by paying delinquent rents. We prevented 272 utility turn-offs by paying delinquent utility bills. We also provided funds for 7 funerals, 40 testing fees for high school diplomas, 4 medical prescriptions, 5 travel tickets. Our food pantry assisted over 300 households with emergency food boxes, and our free coffee house provided coffee and pastry to about 25 homeless individuals each Monday, Wednesday and Friday morning. We also work with neighborhood groups and other social justice organizations to advocate for affordable housing, adult education, living wage, prison reform, etc.

After-school recreation the program provided supervised recreation activities and snacks for neighborhood children on weekdays after school hours. On average, 30 children participated daily.
