Our restoration events facilitate environmental stewardship by Louisiana industries, landowners and business leaders and provide valuable education experiences for its volunteers. Participants learn a variety of restoration methods that are employed across Louisiana's coast. CRCL has engaged more than 1,000 volunteers this year alone and since the program began in 2000 we have worked with over 12,000 volunteers and restored more than 4,700 acres of coastal wetlands.

Management has analyzed the tax positions taken by the Organization, and has concluded that as of June 30, 2017, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Organization is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to income tax examinations for the year ended June 30, 2014 and prior.
