Explanation of large amount on Part III, line 1d

During FYE 6/30/16 the Fire Department received a one-time grant of \$77,550 to purchase structural & wildland fire fighting personal protection clothing (bunker gear). This skewed our total income considerably higher than our normal annual income. Without this grant our three-year average of normal income would have been less than \$50,000. Therefore an e-postcard was filed for FYE 6/30/16.

During FYE 6/30/17, the Fire Department's taxable base increased substantially due to our absorbing another volunteer F.D.'s district. The tax rate also increased therefore our income from property taxes increased to \$73,591 for the year. Since that year's normal annual income increased to well over \$50,000 we are filing this 990-EZ.
