12E SEED CAPITAL COMPANY, LLC MANAGES THE OKLAHOMA SEED CAPITAL FUND, LLC (OSCF), A SERIES OF INVESTMENT FUNDS PROVIDING SEED AND START-UP STAGE EQUITY FINANCING TO SMALL HIGH-GROWTH, TECHNOLOGY-BASED COMPANIES. IT IS AN INNOVATIVE PUBLIC-PRIVATE PARTNERSHIP, DEVELOPED BY OCAST IN PARTNERSHIP WITH 12E, THE OKLAHOMA DEPARTMENT FINANCE AUTHORITY (ODFA) AND THE OKLAHOMA CAPITAL INVESTMENT BOARD (OCIB). INVOLVED AS CO-INVESTORS IN THE FUND'S FIRST SERIES. THE FUND IS AIMED AT HELPING TECHNOLOGY-BASED FIRMS ACCESS THE CAPITAL THEY NEED TO GROW AND CREATE JOBS. CO-INVESTMENT BY ONE OR MORE INVESTORS IS REQUIRED AND BUSINESSES MUST BE LOCATED IN THE STATE OF OKLAHOMA. ACCELERATE OKLAHOMA FUNDS THROUGH AN AGREEMENT WITH THE OKLAHOMA DEPARTMENT OF COMMERCE, 12E ESTABLISHED A PARTNERSHIP WITH THE U.S. DEPARTMENT OF TREASURY AND THE STATES SMALL BUSINESS CREDIT INITIATIVE (SSBCI) TO ALLOW 12E ACCESS TO APPROXIMATELY \$13.1 MILLION IN FUNDING TO BE INVESTED IN OKLAHOMA COMPANIES BEGINNING IN JULY 2011 THROUGH MARCH 2017. IN SEPTEMBER 2012, THE ORGANIZATION ENTERED INTO A GRANT AGREEMENT WITH THE UNITED STATES DEPARTMENT OF COMMERCE'S ECONOMIC DEVELOPMENT ADMINISTRATION ("EDA") TO FUND THE TULSA BUSINESS DEVELOPMENT INITIATIVE. THIS GRANT WAS APPROVED FOR \$393,765 OVER A 36 MONTH PERIOD IN ORDER FOR THE ORGANIZATION TO IMPLEMENT A PILOT BUSINESS DEVELOPMENT INITIATIVE. THIS INITIATIVE OFFERED NEW ENHANCED BUSINESS SERVICES TO ADVANCED TECHNOLOGY START-UP COMPANIES IN THE TULSA AREA. THE PROJECT BROUGHT \$393,765 OF FEDERAL ECONOMIC DEVELOPMENT ASSISTANCE AND \$393,765 OF MATCHING FUNDS FROM LOCAL PARTNERS. EDA FUNDS AND LOCAL MATCHING FUNDS WERE BEING USED TO DEVELOP SERVICES FOR AREA ENTREPRENEURS THAT COMBINE EXECUTIVE-IN-RESIDENCE SERVICES, AN ENTREPRENEUR-IN-RESIDENCE PROGRAM AND THE TULSA VENTURE ASSESSMENT PROGRAM. THE VAP IS A THREE WEEK PROCESS DESIGNED TO INVESTIGATE THE PRODUCT-MARKET FIT AND BUSINESS OPPORTUNITY OF A STARTUP INCLUDING ASSESSMENT OF MARKET NEEDS, DETERMINATION OF POTENTIAL MARKET(S) AND MARKET SIZE, IDENTIFYING POTENTIAL PRICING, IDENTIFYING MARKET BARRIERS, IDENTIFYING PRELIMINARY DISTRIBUTION CHANNELS, IDENTIFYING MARKET TRENDS AND COMPETITORS, AND ESTIMATING PRELIMINARY PROFIT POTENTIAL. THIS GRANT WAS GIVEN A ONE YEAR EXTENSION IN JUNE 2015 AND EXPIRED IN SEPTEMBER, 2016 ON NOVEMBER 14, 2016, 12E WAS AWARDED A GRANT FROM THE U.S. ECONOMIC DEVELOPMENT ADMINISTRATION IN THE AMOUNT OF \$199,749 TO EXPAND ITS VENTURE ASSESSMENT PROGRAM WHICH HELPS REGIONAL BUSINESSES TO IDENTIFY A POTENTIAL MARKET FOR INNOVATIVE CONCEPTS, ESTIMATE THE MARKET SIZE, DETERMINE A PRELIMINARY VALUE OF THE OPPORTUNITY, AND MAKE A PRELIMINARY ASSESSMENT OF WHETHER THE CONCEPT OFFERS SUFFICIENT PROFIT POTENTIAL TO PURSUE ADDITIONAL INVESTMENT OF TIME AND MONEY. LOCAL MATCHING FUNDS TOTALING \$199,749 WERE COMMITTED FROM SIX PARTNERING ORGANIZATIONS. THIS GRANT EXPIRES ON NOVEMBER 14, 2019.
