

The tenant security deposit account is equal to the amount in the tenant security cash account. Tenants are required to make a deposit on the apartment unit that is being leased. When the tenant moves out of the apartment unit if any damages or rent is owed to the project, the project can use the deposit for payment and then refund any additional funds that may be available.
